Dan M. Shepherd, 76, of San Jose, Illinois, passed away on November 9, 2024, at Springfield Memorial Hospital in Springfield, Illinois, surrounded by his family. He was born March 16, 1948, to Orin and Lorraine (nee Pergande) Shepherd.

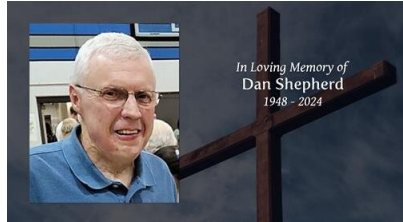
