Lawrence "Larry" Austin Hollis, 68, of Petersburg, Illinois, passed away at Memorial Medical Center in Springfield on Monday, November 4, 2019, surrounded by his loving family. He was born on May 4, 1951 in Springfield, Illinois, the son of John H. and Lois Jane Hollis.

Larry served our grateful nation in the Illinois Army National Guard. From there he returned to the family farm with his father, later joining the Menard County Sheriff's Office, where he retired at the rank of Captain. After retiring from the sheriff's office, he worked for the United States Marshals Service, Central District of Illinois. Larry proudly served as the Menard County Coroner for over 26 years, up until the time of his passing. He was a member of the St. Peter's Catholic Church, a long-time member of the Clinton Masonic Lodge #19 and a member of the Tallula Sportsman's Club. He was a past member of the Menard County Rescue Squad and previously served as an EMT for the former Menard Ambulance Service. He still routinely assisted the sheriff's office with his insight and knowledge. His ability to retain knowledge and information from the past was second to none.

Larry found great joy in the company and happiness of others. He enjoyed light-hearted times with everyone he knew. Regardless of the situation, he found a way to make the best of it. He was the best at "turning lemons into lemonade". He found a way to do so much for so many, never expecting anything in return.

Larry is survived by his wife, Jennifer Hollis; two children, Ben Hollis (Brittin

Armour) of Petersburg and Katelyn (R.J.) Green of Mason City; one step-daughter, Kristin Reid of Petersburg; two grandchildren, Harlyn and Kylie Green of Mason City; a sister, Holly Hollis of Petersburg; and former spouse and loving friend Mary Sutton Chang of Kaneohe, HI.

Larry was preceded in death by his parents, John and Lois Jane (Austin) Hollis; and a nephew, Justin Leach.
